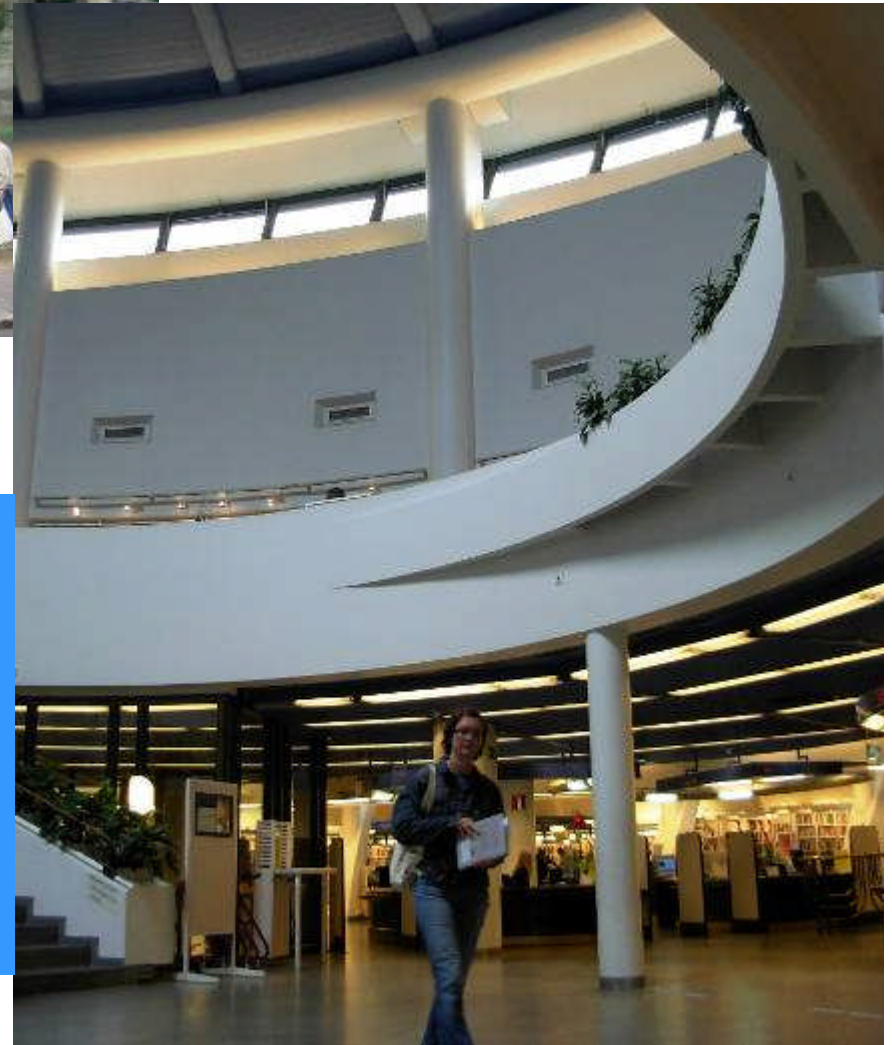

Olkiluoto, Atom-Metropole im Aufwind – wie überall: ohne Deponie ...

Protest at Olkiluoto nuclear plant construction site

30 May 2007

Six Greenpeace activists continue their two-day occupation of a 100-meter-high construction crane at the heart of the reactor Olkiluoto 3 construction site in Finland. The activists have positioned themselves 80 meter up in the crane. The occupation is a protest against the 1500 safety problems that have been revealed during construction of the plant.

Olkiluoto, Finland — On Monday, activists blockaded the entrance to the Olkiluoto nuclear plant construction site - briefly shutting down a project already massively over budget and plagued by more than one thousand reported breaches of safety standards.

Update (31 May): The EU Energy Commissioner is prepared to meet with Greenpeace during his visit to the nuclear reactor Olkiluoto 3 construction site tomorrow.

Update (1 June): We met with the EU Energy Commission today, and he agreed there should be more transparency and openness. The last three activists have come down and are safe.

Environmental Impact Assessment (EIA)

is a statutory process in which

- environmental impacts of various realization alternatives of the project are assessed. All affected parties may participate in the EIA process.
- environmental and social aspects are assessed along with technical and economical aspects.
- citizens' possibilities to participate and express their opinions on the project are increased.
- no decision on the realization of the project is made.

Environmental impacts are assessed widely in the EIA

and they relate to:

- people's health, living conditions and comfort
- soil, water areas, air, climate, flora, living organisms and the diversity of the nature
- urban structure, buildings, landscape, townscape and cultural heritage
- utilization of natural resources.

Time schedule

According to TVO's estimate, the EIA process will take at least a year. Based on the planned time schedule, the EIA process will be completed in summer 2008.

Why TVO starts the EIA process just now?

- Based on the Finnish energy and climate policy outline, by launching the EIA process TVO maintains preparedness for constructing additional capacity at Olkiluoto.
- The EIA report is required for a possible application for a decision-in-principle. Neither a decision on the submission of an application for a decision-in-principle for a new nuclear unit nor on the realization of the project has been made.
- The licensing and realization process of a nuclear power plant unit is long, and it takes years from the launching of the EIA process until the unit starts operation.

The Ministry of Trade and Industry as a contact authority

- The Ministry of Trade and Industry (KTM) guides and supervises the EIA process in nuclear power plant projects as a contact authority. The Ministry
 - examines when the assessment programme and report are on file for public inspection
 - collects the given opinions and statements
 - prepares their own statement based on the given opinions and statements

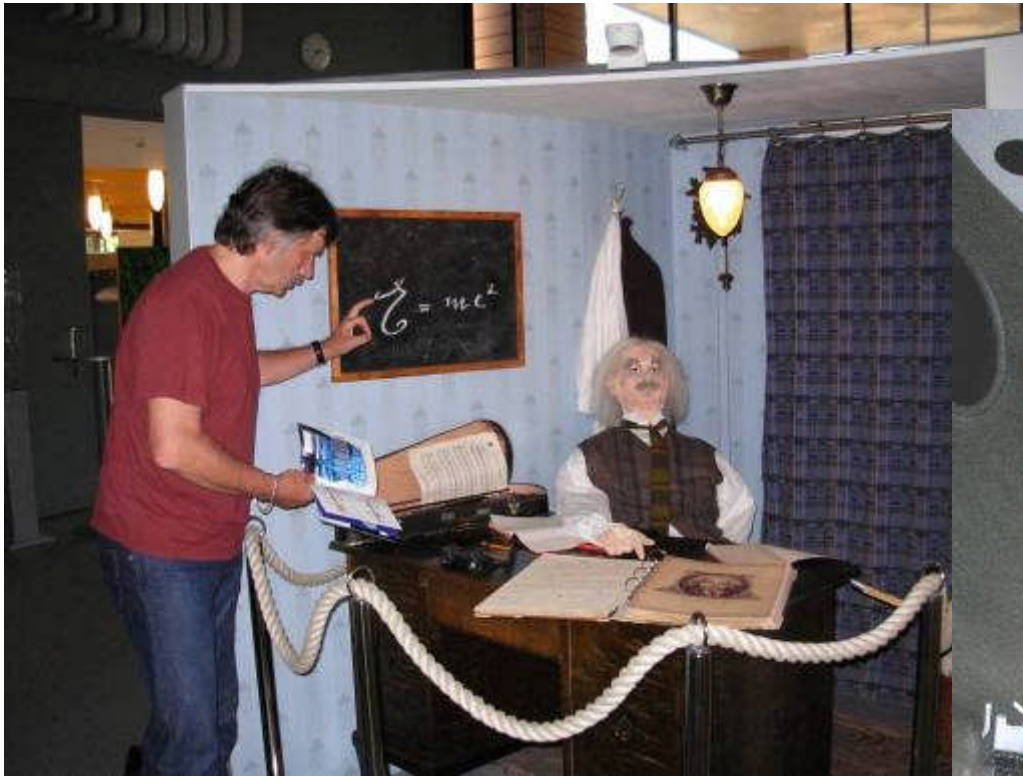
The citizens are free to express their opinions on the EIA process to the contact authority KTM.

The Ministry is responsible for the instructional public hearings in the EIA process.

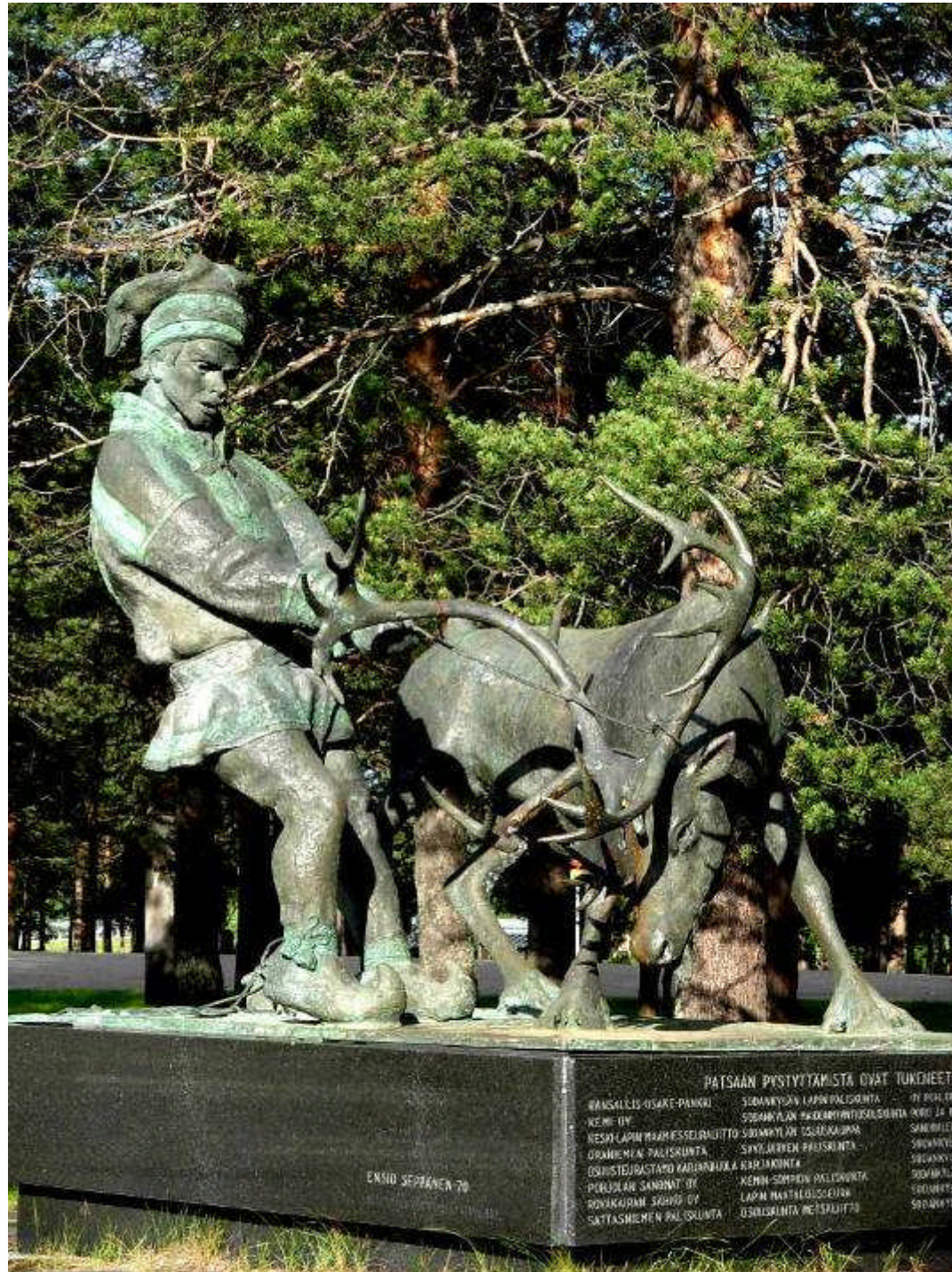
